#### 1. Overview of Trademarks

A trademark is a word, phrase, symbol, design, or combination thereof that identifies and distinguishes the source of goods or services of one party from those of others. Trademarks are used to protect brand names and logos used on goods and services.

## 2. Benefits of Trademark Registration

- Exclusive Rights: Grants the exclusive right to use the trademark in connection with the goods or services listed in the registration.
- **Public Notice**: Provides public notice of your ownership of the mark.
- Legal Protection: Gives you the ability to take legal action against others who use your mark without permission.
- Nationwide Protection: Offers nationwide protection for the mark, rather than being limited to the geographic area of use.
- Customs Enforcement: Allows you to record the trademark with the U.S. Customs and Border Protection to prevent importation of infringing goods.

# 3. Types of Trademarks

- Standard Character Mark: Protects the words themselves, regardless of how they are stylized.
- Stylized/Design Mark: Protects the specific design or stylized presentation of the mark.

- Composite Mark: Includes both words and a design.
- Service Mark: Used to identify and distinguish the services of one provider from those of others.

### 4. Steps to Register a Trademark

#### **Step 1: Conduct a Trademark Search**

Before applying, conduct a trademark search to ensure your mark is not already in use. You can use the United States Patent and Trademark Office (USPTO) Trademark Electronic Search System (TESS) for this purpose.

- 1. Visit the TESS Website: Go to TESS.
- 2. Search for Similar Marks: Enter your mark and search for existing trademarks that are similar to yours.

#### **Step 2: Determine the Basis for Filing**

You can file a trademark application based on:

- **Use in Commerce**: If you are already using the mark in commerce.
- **Intent to Use**: If you plan to use the mark in the future.

### **Step 3: Prepare Your Application**

Gather the necessary information for your application:

- Owner's name and address
- Clear representation of the mark
- Description of goods or services
- Basis for filing (use in commerce or intent to use)

#### **Step 4: File the Application Online**

- 1. **Visit the USPTO Website**: Go to USPTO Trademark Application.
- 2. Select TEAS Form: Choose the appropriate TEAS (Trademark Electronic Application System) form:
  - TEAS Plus: Lower filing fee, but stricter requirements.
  - TEAS Standard: Higher filing fee, but more flexibility.
- 3. Complete the Application: Fill out the application form with all required information.
- 4. Pay the Filing Fee: The fee varies depending on the type of application (TEAS Plus or TEAS Standard).

### **Step 5: Monitor the Application Process**

After filing, monitor the status of your application through the USPTO's Trademark Status and Document Retrieval (TSDR) system.

- 1. **Visit TSDR**: Go to TSDR.
- 2. Enter Application Number: Enter your application number to track its status.

#### **Step 6: Respond to Office Actions**

If the USPTO issues an Office Action (an official letter requiring additional information or corrections), respond promptly to address any issues.

### **Step 7: Publication and Opposition**

If the application passes the initial review, it will be published in the Official Gazette. During this time, third parties can file an opposition to your registration.

### **Step 8: Registration Certificate**

If no opposition is filed, or if you overcome any opposition, the USPTO will issue a registration certificate.

## 5. Post-Registration Steps

#### Step 1: Use the ® Symbol

Once your trademark is registered, use the ® symbol to indicate that the mark is registered with the USPTO.

#### Step 2: Maintain Your Trademark

To keep your trademark registration active, you must file periodic maintenance documents:

- Between the 5th and 6th Year: File a Section 8 Declaration of Continued Use.
- Between the 9th and 10th Year: File a combined Section 8 Declaration and Section 9 Application for Renewal.
- Every 10 Years: Continue to file a combined Section 8 and Section 9 every ten years.

### **Step 3: Monitor and Enforce Your Trademark**

Regularly monitor the marketplace for potential infringement and take action to enforce your rights if necessary.
